## Bond

KNOW ALL MEN BY THESE PRESENTS:

2019-2020 by virtue of Act 544 of the 2019 General Assembly of the State of Arkansas.

(1) Using the funds allotted of said Arkansas 4H Association under said law 2019-2020 Act 544 to pay travel and expenses incurred by members for representing the state of Arkansas at national conferences and events outside the state during said fiscal year.

(2) Filing with the Livestock & Poultry Commission not later than sixty (60) days after the conclusion of said fiscal year, an itemized list, supported by canceled checks and applicable invoices and receipts; and

(3) Returning to the Livestock & Poultry Commission, not later than ninety (90) days after the conclusion of said fiscal year, all of the funds theretofore received from the state of Arkansas during the fiscal year 20\_\_\_\_\_ which were not used in paying said expenses.
