Please complete this application for Quality Assurance (QA), Identity Preserved (IP), or Service Inspections (SI). Submit one form for each variety name, detailed maps for each field, field planting dates, and correct breeder descriptions for each variety (if applicable). You may include your own list, but this form must be signed, dated, and accompany your list of fields and varieties. A field inspection form will be designed for your specific needs, or, you may utilize your own form if it is approved by the Seed Certification Office. Notify your Arkansas Department of Agriculture Area Inspector at least one week ahead of each inspection. Fees are based on the type and complexity of each inspection. If this crop will be exported to another country, or should you have any questions, contact us. An Arkansas Seed Labeler's License (Seed Dealers License) is required if this seed is to be sold for planting purposes within the State of Arkansas.

- _____ **MAPPING: 3 to 10 GPS coordinates will be collected depending on each field size.**
- _____ **FLOWERING: 10 counts of 500 plants for flower color will be collected for each field.**
- _____ **PUBESCENCE: 10 counts of 500 plants will be examined for consistency with the variety's description.**
- _____ **OTHER CROPS / OTHER VARIETIES: 10 counts of 500 plants will be collected to determine other varieties or crops present, or, you may choose to have the field inspected only for the presence and number of visible other crops or varieties.**
- _____ **NOXIOUS WEEDS: Fields will be inspected for the presence and number of visible Arkansas noxious weeds, or you may specify weeds you want noted.**
