of Arkansas as a registrant to engage in business as a Catfish Processor and operate the

registered catfish processor, in conformity with the provisions of the Arkansas Catfish Fair
Practices Law, Act 365 of 1987 and the rules and regulations promulgated thereunder, and all
additional obligations as said Principal may assume under contracts with persons delivering
catfish in the facility, then this obligation shall be void, otherwise to remain in full force and effect
during the term of the registration and its extension or annual renewal.

In no event shall the liability of the surety accumulate for each successive registration
period during which this bond is in force, but shall be limited in the aggregate to the bond amount
stated above, or changed by appropriate rider(s) or endorsement(s).

This bond shall become effective on _____, 20 ____ and shall
continue in full force and effect until canceled. Provided, that this bond may not be canceled by the
Principal or Surety named herein, except in accordance with the provisions of Act 365 of 1987 and
Regulations, which requires, in part, that the Principal or Surety provide thirty days written
notice of cancellation, sent by certified mail, to the Director of the Arkansas Plant Industries
Division, 1 Natural Resources Dr., Little Rock, Arkansas 72205.
