INSTRUCTIONS: Complete and mail with fees due to: Arkansas Department of Agriculture - Plant Industries Division, ATTN: Feed Section, 1 Natural Resources Dr., Little Rock, Arkansas 72205. Quarters end each March 31, June 30, Sept. 30 and Dec. 31. Submit a for for each location. A minimum inspection fee of ten dollars (\$10.00) shall be paid on quarterly sales of 0 to 33.34 tons. Make checks payable to: Arkansas Department of Agriculture. Tonnage reports and fees must be sent not later than 15 days after the last day of Jan. April, July, and Oct. as evidenced by the postmark date. The fee for a late report is fifteen percent (15%) or twenty-five dollars (\$25.00) whichever is higher added to the amount due.
